BY ORDER OF THE COURT:

This cause shall proceed as an appeal of a final order. See Florida House of Representatives v. Expedia, Inc., 85 So. 3d 517, 520 (Fla. 1st DCA 2012). Consideration and disposition of the appeal is expedited on the court's own motion. No extensions of time shall be entertained by this court on any matters related to this proceeding absent a genuine showing of emergency circumstances. In order to ensure a speedy disposition of this appeal, this cause shall proceed on the basis of the briefs and appendices alone, without the filing of a record on appeal.

Appellants' motion for stay filed May 15, 2014, is granted, and the lower tribunal's orders of May 2, 2014, and May 15, 2014, are stayed pending final disposition of this proceeding or further order of the court.

At or before 5:00 p.m. on Monday, May 19, 2014, appellants shall file an appendix containing (1) transcripts of any proceedings held before Special Master Harding; (2) a transcript of the proceedings held on May 9, 2014; and (3) any other portions of the record of proceedings before the lower tribunal deemed necessary for the court's consideration.

Appellants shall also file at or before 5:00 p.m. on Monday, May 19, 2014, a supplemental appendix, clearly marked "CONFIDENTIAL," containing the 538 pages of documents deemed confidential by the lower tribunal which are the subject of the orders on appeal. The supplemental appendix shall be maintained by the clerk of this court under seal. See Fla. R. Jud. Admin. 2.420(g)(8).

Appellants shall file an initial brief by no later than 5:00 p.m., Monday, May 19, 2014, and answer briefs shall be filed by no later than 5:00 p.m., Tuesday, May 20, 2014. Appellees may include appendices with their answer briefs containing any materials from the lower court proceedings which appellees deem relevant to this appeal not contained in the appellants' appendices.

Any reply brief shall be filed by no later than 12:00 p.m., Wednesday, May 21, 2014.
